2023 IFSC EUROPEAN QUALIFIER QUALIFICATION SYSTEM

1. Introduction

The current document outlines the Qualification System of the 2023 IFSC European Qualifiers for the IFSC National Federations.

2. European Qualifiers

Member Federations may register eligible Team Members in the numbers and capacity following:

- A) Team Officials
 - 1) One (1) Team Manager;
 - 2) Two (2) coaches;
 - 3) Two (2) qualified medical personnel, and

The above article applies for both the IFSC European Qualifier in Speed and IFSC European Qualifier in Boulder & Lead

3. Speed European Qualifier

Member Federations may register eligible Team Members in the numbers and capacities following:

- B) Competitors
 - 1) four (4) competitors per gender

For the avoidance of doubts, there will be no extra quota for the Host Country. The deadline for registrations will be published in the relevant info sheet.

4. Boulder & Lead European Qualifier

The following two rankings will be used to determine the Qualification to the Boulder & Lead European Qualifier, for each gender:

- 2023 IFSC World Cup National Team Ranking (NTR)
- 2023 IFSC European Cups National Team Ranking (ENTR)

The deadline for the use of such ranking will be the 26th of September 2023

4.1. 2023 IFSC World Cup National Team Ranking (NTR)

In order to create an IFSC Boulder & Lead ranking, the following mechanism will apply:

- a) Only the National Teams which have a valid ranking in both disciplines (Boulder and Lead), will be eligible for the ranking
- b) The IFSC will create the B&L ranking by adding the points gathered by the National Team in both disciplines (Boulder + Lead)

For the avoidance of doubts, the single discipline points will be taken from the IFSC National Team Ranking, as for IFSC rules. The points will not be specifically re-calculated for European Countries

4.2. 2023 IFSC B&L European Cups National Team Ranking

In order to compile an IFSC Boulder & Lead ranking, the following mechanism will apply:

- a) Only the National Teams which have a valid ranking in both disciplines (Boulder and Lead), will be eligible for the ranking
- b) The IFSC will create the B&L ranking by adding the points gathered by the National Team in both disciplines (Boulder + Lead)

For the avoidance of doubts, the single discipline points will be taken from the IFSC National Team Ranking, as for IFSC European rules.

5. Boulder & Lead Summary table

Europe Qualification System B&L (for each gender)			Quotas assigned

В	2023 IFSC World Cups National Team Ranking (B+L)	8 th to 15 th European NFs	1 per Country
С	2023 IFSC European Cups National Team Ranking (B+L)	1 st to 7 th European NFs	1 per Country
D	Fixed quota	One guaranteed quota	1 per Country

All the quotas will be assigned to the corresponding National Federation, not to the single athlete

Example = Country X, which will be ranked for Women on 3^{rd} place on the NTR and 6^{th} place at the ENTR will get 4 quotas (2+1+1)

6. Eligibility of athletes and National Federations

- Already qualified athletes who have obtained the qualification to the 2024 Olympic Games through the 2023 IFSC WCH in Bern (SUI) are not eligible to take part in the European Qualifiers
- The Countries which already filled their Paris NOCs quota from the IFSC World Championships in Bern (SUI) will not be eligible to take part in the European Qualifiers, for the respective discipline/gender
