1. General

1.1. The IFSC may approve each year the organisation of a series of competitions in each of the Boulder, Lead and Speed Disciplines (the "Climbing World Cup" or "World Cup"), in each case with a maximum of eight (8) competitions in each discipline.

2. Eligibility

- 2.1. Eligibility to participate in any *World Cup* event as a team officials or a competitor is limited to individuals:
 - 2.1.1. holding a valid *International Licence* for the current year;
 - 2.1.2. who are or will be at least 16 years of age in the year of the event;
 - 2.1.3. who are not currently suspended from competition by the IFSC for any reason, and
 - 2.1.4. who are registered for the relevent event by their *Member Federation*.

3. Registration of Team Officials & Competitors

- 3.1. Currently eligible *Member Federations* may, within the published deadlines, register *Team Officials* at any *World Cup* event in the capacity and number set out in Table 1 (*Team Officials*)
- 3.2. Currently eligible *Member Federations* may, within the published deadlines, register for each gender category and discipline of the relevant *World Cup* event as follow:
 - 3.2.1. Any currently-eligible competitors ranked 10th or better in the relevant *World Ranking* as the start of the calendar year (*Extra Quota* competitors);
 - 3.2.2. In addition to specific individuals covered above, up to two (2) currently-eligible competitors;
 - 3.2.3. In addition to the individuals covered above, up to an additional four (4) competitors where the *Member Federation* is the host nation; and
 - 3.2.4. an additional number of competitors where the *Member Federation* has an *Additional Quota* in a relevant gender category and discipline, up to the number of that *Additional Quota*.
- 3.3. The Additional Quota for each Member Federation in each gender category and discipline will be determined by the number of competitors from each Member Federation ranked between 11th and 40th in the relevant World Ranking as at the end of the previous year using the values set out in Table 2 (Additional Quota).



3.4. The IFSC will publish annually a list of *Extra Quota* competitors and the calculated *Additional Quota* in each gender category and discipline for each relevant *Member Federation* not later than 31 January each year. Any subsequent additions/deletions from this list will require the approval of the IFSC Executive Board and will be published on the IFSC website and communicated directly to all *Member Federations* by the IFSC Sport Department.
